As the United Nations' specialized agency for health, the World Health Organization (WHO) provides global leadership on health issues, including pandemics. The WHO is responsible for setting evidence based global technical norms, standards and policy options, and monitors global health trends and assists Member States.

# Lessons learned from COVID-19

 Denmark strongly recognizes the need to learn from the COVID-19 crisis, including by ensuring an independent evaluation and clear multilateral responses through a strengthened WHO

## Governance and the global goods

- Denmark will continue to push for a rights-based approach to WHO's work
- The normative role of WHO is the core of its mandate and Denmark will work to make this a continuous priority across the organisation
- Denmark will continue to support the process of ensuring good governance, sound financial management and an efficient, effective and accountable WHO

#### Technical priorities

- Denmark prioritizes the implementation of the 13th General Programme of Work (GPW13) and achieving its triple billion goals. Denmark will support this work with a focus on:
  - achieving universal health coverage
  - reducing health inequalities
  - strengthening public health
  - ensuring resilient and universal health systems
- WHO is a vital leading partner in the global response to health emergencies.
  Denmark will work to support timely and focused preparedness and response, including full implementation of the IHR
- Denmark remains fully committed to the fight against antimicrobial resistance and strongly supports the One Health approach. Denmark supports the WHO as a key partner in the global response

#### The Danish candidate; Dr Søren Brostrøm

Dr Brostrøm was appointed Director General of the Danish Health Authority in 2015. He represents Denmark in WHO and other international forums and chairs the 27th Standing Committee of the WHO Regional Committee for Europe.

Dr Brostrøm has extensive clinical and academic experience and has served in numerous positions in national and international scientific societies. He completed a MPA from Copenhagen Business School in 2011.

Dr Brostrøm joined the Danish Health Authority in 2011 as Head of Hospital Services & Emergency Management, with broad responsibilities for the national planning of specialized hospital services, emergency services and preparedness, communicable diseases, immunization and screening programmes, as well as national action plans on cancer, cardiovascular diseases and mental health.

Before joining the Danish Health Authority, Dr Brostrøm worked as a Senior Consultant Urogynaecologist at the University Hospital of Copenhagen and as Associate Professor at the University of Copenhagen.

Dr Søren Brostrøm holds a MD degree from the University of Copenhagen, where he also obtained a PhD degree in neurophysiology in 2003. He specialized in gynaecology and obstetrics, with a subspecialisation in urogynaecology.
