Introduction

The UAR stakeholder meeting will take place at a time when zoonotic diseases and One Health are high on the global agenda.

As one of the oldest known zoonoses, rabies is entirely preventable, yet remains a major public health problem, particularly in Africa and Asia. However, rabies control and elimination is possible through a united One Health approach that strengthens human and animal health systems and drives progress towards the Sustainable Development Goals.

The framework for this approach is set out in *The Global Strategic Plan to end human deaths from dog-mediated rabies by 2030* and a United Against Rabies Forum to deliver its vision will be announced at this event. **To make rabies elimination a reality by 2030, we need all sectors to join forces – government, animal and human health, research, private sector and civil society.**

The Tripartite (FAO, OIE and WHO) will support the stakeholder meeting to create an enabling environment so that members and countries can focus on activities that efficiently contribute to *Zero by 30*, while also sharing of knowledge, experience, ideas, and information.
