# Nominating a focal point for a Coalition of Partners initiative to strengthen public health capacities and services in the European Region

In 2016, a mid-term progress report on the implementation of the European Action Plan to Strengthen Public Health Capacities and Services was presented at the 66<sup>th</sup> meeting of the WHO Regional Committee for Europe, recommending that additional efforts be invested in engaging partner organizations. In response, in January 2017, the Regional Office launched the Coalition of Partners to Strengthen Public Health Services and Capacities in the European Region.

The Coalition of Partners initiative is a collaborative platform that brings together experts and practitioners from within national public health services, international organizations, civil society and academia. The approach is highly participatory and action oriented, inviting partners to jointly cocreate an agenda for action and form solutions to strengthen public health services at the national level while emphasizing the need to take joint responsibility for implementation. The Coalition of Partners focuses its efforts on the enabler functions of public health services: human resources for public health, financing of public health services, organization and governance of public health services and legislation to enable public health services.

The Coalition of Partners convened for the first time in January 2017 in Copenhagen, Denmark and again in November 2017 in Helsinki, Finland. As a result, several collaborative projects were initiated as a part of its Agenda for Action, including developing tools and delivering joint capacity-building activities at the country level.
