TO ALL MEMBER STATES IN THE WHO EUROPEAN REGION

Dear Sir or Madam,

I have the honour to inform you that, in accordance with Rules 14.2.2 and 14.3 of the Rules of Procedure of the WHO Regional Committee for Europe, nominations for membership of the following WHO bodies and committees must be received by the WHO Regional Office for Europe no later than 15 March 2019. Each candidature must be accompanied by a curriculum vitae in standard format. Copies of the curriculum vitae forms are attached.

At its 69th session, to be convened from 16 to 19 September 2019, the Regional Committee will select or elect members for the bodies and committees listed below.

I would like to draw your attention to resolution EUR/RC63/R7 and its annexes 1, 2 and 3 (available at http://www.euro.who.int/en/about-us/governance/regional-committee-for-europe/sixty-third-session/resolutions-and-decisions/eurrc63r7-governance-of-the-who-regional-office-for-europe) on membership of the Executive Board and of the Standing Committee of the Regional Committee for Europe, which provide, inter alia, for the alternating seat moving between Group A and Group B, and the periodicity of membership of the Executive Board for those Member States in the European Region that are permanent members of the United Nations Security Council.

Executive Board

Two seats on the Executive Board (EB) will become vacant at the closing of the Seventy-third session of the World Health Assembly in May 2020, when the terms of office of the members designated by Georgia and Italy will expire.

According to Annex 3.A of resolution EUR/RC63/R7, the following seats will be available:

- one vacant seat in Group A;
- no vacant seat in Group B;
- one vacant seat in Group C.

Standing Committee of the Regional Committee for Europe

Four seats on the Standing Committee of the Regional Committee for Europe (SCRC) will become vacant at the closing of the 69th session of the Regional Committee, when the terms of office of Greece, Slovakia, Slovenia and Turkey will expire.

According to Annex 3.B of resolution EUR/RC63/R7, the following seats will be available:

- one vacant seat in Group A;
- two vacant seats in Group B;
- one vacant seat in Group C.

Nominations for membership of WHO bodies and committees

Curriculum vitae forms in standard format, to be completed for candidates for the above-mentioned bodies and committees, are attached. The forms are also accessible via https://euro.sharefile.com

Additionally, I wish to draw your attention to Rules 14.2.2(a) and 14.3 of the Rules of Procedure of the Regional Committee, which require Member States presenting their candidacy for the Executive Board or the SCRC to submit, together with the curriculum vitae of the representative they intend to appoint if elected, a letter of intent.

The letter of intent must be written in one of the four official languages of the WHO European Region and should not exceed 600 words in length.

Its content should include a short description of the following items:

- an overview of the key elements of the relations between WHO and the nominating Member State, including events or programmes of particular relevance to the Member State concerned;
- which WHO priorities the nominating Member State plans to represent during its threeyear membership term;
- how the nominating Member State plans to achieve those priorities during the three-year term, and the reasons why the Member State is applying for membership of a governing body.

To facilitate a comparative consideration of the candidacies submitted by Member States, the letter of intent may include:

- 1. a record of Member States' engagement with WHO's governance and technical activities; for example, active participation in governing bodies meetings, or in special programmes such as TDR and HRP, active participation and involvement in intergovernmental negotiations launched under the aegis of WHO, compliance with reporting requirements to WHO at regional or global level, as well as other examples considered relevant by Member States to demonstrate a high level of engagement with WHO;
- 2. details and evidence of their commitment to the implementation of global and regional WHO policies considered as a priority by them within the framework of their national health policies as well as their foreign policy;
- 3. details of how they aim to engage and cooperate with WHO if elected, and the contributions they intend to make as members of the SCRC or the Executive Board.

Before the opening of the Seventy-second World Health Assembly in May 2019, the Regional Director will notify all Member States of the WHO European Region of the nominations received by the deadline of 15 March 2019, together with the curricula vitae in standard format, and the letters of intent of the intended representatives. Only nominations so received will be presented to the Regional Committee at its 69th session in September 2019. Advance copies of nominations, curricula vitae and letters of intent should be submitted to the following email address: eugovernance@who.int.

At its third and fourth sessions in 2019, in March and May respectively, the Twenty-sixth SCRC will review all nominations received, with the aim of agreeing on a list of candidates equal to the number of seats to be filled. The countries not recommended for short-listing may expect to be contacted by the Standing Committee before the 69th session of the Regional Committee.

I would like to further draw your attention to the provisions of Rule 14.2.2(d) of the Rules of Procedure: "Member States having submitted nominations must be represented at the Regional Committee during the relevant agenda item otherwise their nominations will not be considered."

Finally, I take this opportunity to inform you that the Twenty-seventh SCRC will hold its first session on the final day of the 69th session of the Regional Committee, on Thursday, 19 September 2019, during the lunch break. Member States submitting nominations to the SCRC are therefore encouraged to make arrangements for their representatives, if elected, to be present at the first session of the Twenty-seventh SCRC.
