Background: Britain's Medicines and Healthcare products Regulatory Agency (MHRA) authorised the AstraZeneca-Oxford vaccine on the conditions that the vaccine should be administered in two doses, with the second dose given between 4 and 12 weeks after the first. AstraZeneca had signed an agreement with Serum Institute of India (SII) to produce 1 billion doses of its experimental vaccine for lowand middle-income countries.

Origin: Astrazeneca Licensed Manufacturing Plant in India (Serum Institute of

India/SII) OR UK

Approval: Brazil, UK, INDIA, Argentina, Mexico, Dominican Republic Storage & Transportation: This Vaccine can be stored and transported at normal refrigerated temps of 2 degrees to 8 degrees Celsius (36 degrees to 46degrees Fahrenheit) for at least six months. The vials shall be shipped via Temperature controlled AIR shipment handled by one of the many global cold chain logistics service providers directly contracted by the factory.
