The programme includes plenary and parallel sessions. Specific themes will be addressed in key note lectures and working group discussions.

The objectives of the meeting are to:

- present the latest evidence for development of effective TB prevention and care policies;
- exchange experiences in implementation of effective TB prevention and care policies;
- discuss implementation progress of National TB Action Plans in line with the End TB Strategy and the Regional TB Action Plan 2016- 2020;
- discuss aspects pertaining to TB in migrants, collaborative TB/HIV activities, quality people-centred care, new and repurposed drugs' introduction and active drug safety monitoring, and digital health.

The working languages will be English and Russian, and simultaneous interpretation will be provided.

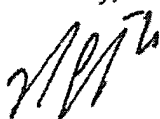
