- Gather competent authorities responsible for medicines financing and pharmaceutical policy making so to promote collaboration on Universal Health Coverage;
- Focus on access to essential medicines and reduction of out-of-pocket (OOP) payment for medicines and facilitate introduction of sound policies regulating the price and reimbursement of medicines;
- Share of best practices and provide training opportunities.

This meeting is a follow-up to the kick off meeting which took place in Chisinau, The Republic of Moldova, on June 13<sup>th</sup> and 14<sup>th</sup> 2017. The specific objectives of this second session will be:

- To discuss the pricing and reimbursement country profiles in preparation of the WHO publication on this topic;
- To share experience on how to handle medicines financing policies during the transition from donor funded program to national resources;
- To have concrete technical discussion on implementation of pricing policies and utilization of Intellectual Property Rights related flexibilities;
- To discuss and decide on the content of next follow up meeting of the CIS PPRI network, creation of a secretariat and dedicated mailing list for on-line consultations and interaction between network meeting.
