# Training of Trainers: Smokefree Legislation Training for Enforcement Officers in Georgia, 2018

A one-day training course with 2 consultants from the Secretariat of the FCTC assisted by staff of the WHO Country Office for Georgia.

#### Who should attend?

Officers of the Ministry of the Interior and other persons who will be responsible for organising and/or delivering the training and/or guidance of police and other officers in enforcement duties for securing compliance with smokefree legislation.

All attendees will have experience of developing and delivering training and/or guidance in enforcement activities within a regulatory environment or have expert knowledge of tobacco control and smokefree requirements.

#### Aims of the course:

To demonstrate proposed content of the training for enforcement officers with regulatory responsibilities for smokefree legislation.

To consider the proposed training and workshop materials and assess their suitability for adaptation and adoption.

### **Key outcomes:**

Delegates who have attended this Training for Trainers will be able to decide upon the final content of the training or guidance for enforcement officers with regulatory responsibilities for smokefree legislation, including:

- Be aware of the expectations of FCTC Article 8 for the delivery of compliance
- Have considered the public health implications of smokefree legislation
- Be familiar with the requirements of the smokefree legislation to be implemented on 1<sup>st</sup> May 2018
- Have discussed the conduct of the procedures for securing compliance, including inspection and enforcement measures
- Have considered and assessed the application of the legislation and the enforcement measures in a variety of situations
- Be aware of the role of key partners, sources of information and on-going support for enforcement officers
