Hospital Safety Index Training and Assessment Tbilisi, Georgia 12-16 June 2017

On behalf of the World Health Organization (WHO), I have the honour of informing you that the WHO Regional Office for Europe would like to hold the above-mentioned Hospital Safety Index Training and Assessment in Tbilisi, Georgia, from 12-16 June, 2017.

I am therefore enquiring whether your Ministry would be willing to act as host, and would be willing to organise and facilitate visits to two (2) key hospitals in Tbilisi or surrounding area for the participants and the designated WHO officials.

The purpose of the assessment is to give the hospital managers and the Ministry of Health an overall idea of a hospital's ability to respond to emergencies and disasters through an index, which is a standardized assessment tool developed by the World Health Organization. The assessment part is not an evaluation of the medical performance, but an assessment of the safety of the buildings and their equipment, staff, patients and visitors. A questionnaire will be used for this purpose. For your information, please find attached an outline of the scope and purpose of the training and assessment.

The training and follow up assessment is expected to provide better knowledge and understanding of the overall findings and recommended implementations, which will be presented in an action plan.
