I feel privileged to be able to present to you the Belgian company Cross-Border Solutions byba ("CBS"). CBS is Belgian a services provider for international project development. As you may know, such instruments can only be issued to promote projects that are sustainable and not-for-profit. It is also required that these projects fit within the national priorities as determined by the Georgia government.

In view of our mission to develop such project(s) with Belgian exporters, I would greatly appreciate the opportunity to discuss with the local stakeholders what the current economic priorities would be for the Georgia government and maybe obtain guidance on what procedures need to be complied with.
