**Workshop on Strengthening Resource Mobilization Efforts
8-10 November 2017, Copenhagen, Denmark**

I was pleased to learn that you have been nominated by your Government to participate in the above workshop.

The Vaccine Alliance (Gavi) country support model gradually increases country co-financing of vaccines towards a final and complete transition from Gavi support. The model necessitates intensified resource mobilization efforts to raise additional funding for vaccines, particularly from domestic resources.

The WHO Regional Office for Europe is pleased to provide further technical support to the national immunization programme and Ministry of Health staff in strengthening resource mobilization efforts in Gavi supported countries. In this context, building on previous advocacy and resource mobilization workshops and guiding materials developed by the WHO Regional Office for Europe, a three-day workshop will be organized where participants will have opportunity to develop country-specific advocacy materials to be used for in-country resource mobilization activities. Countries will also be assisted to develop their resource mobilization plans, which will be technically and financially supported by WHO in the implementation phase.

An outline of the scope and purpose of the workshop is enclosed.

The participants to this workshop will include Ministry of Health officials from seven Member States (Armenia, Azerbaijan, Georgia, Kyrgyzstan, Republic of Moldova, Tajikistan and Uzbekistan) designated by their governments, technical staff from the Regional Office and Country Offices and representatives of other partner agencies.

The working languages will be English and Russian and simultaneous interpretation will be provided.

Instructions will be given to Carlson Wagonlit Travel (CWT) in Copenhagen concerning your ticket for round trip travel by the most direct route, by train (first class) and/or air (economy class), who will provide you with your travel ticket.
