WHO European Regional meeting of National Immunization Programme Managers and the 17th meeting of the European Technical Advisory Group of Experts (ETAGE) Budva, Montenegro, 24-27 October 2017

I have the honour to inform you that the WHO Regional Office for Europe plans to hold the abovementioned meetings.

Under the auspices of the Minister of Health, Montenegro, a meeting of National Immunization Programme Managers from 53 Member States in the WHO European Region will be held on 24, 25 and 26 (morning) October 2017, followed by the annual meeting of the European Technical Advisory Group of Experts (ETAGE) on 26 (afternoon) and 27 October in Budva, Montenegro.

We expect approximately 150 participants from 53 Member States of the WHO European Region as well as experts from the WHO and international partners, to take part in the Programme Managers Meeting (PMM). The objectives of the meeting are to present and discuss the progress and challenges in meeting the five strategic objectives of the European Vaccine Action Plan 2015-2020 (EVAP), exchange experiences, promising practices and country case studies and define key priority areas for accelerated action under each strategic objective.

The annual ETAGE meeting will be held immediately following the PMM. ETAGE is an advisory body tasked with providing independent review and technical input to the WHO Regional Director in relation to the eradication, elimination and control of vaccine-preventable diseases in the WHO European Region.

I have pleasure in inviting you to nominate two participants, including the *National Immunization Programme Manager* and the *Chair of the National Immunization Technical Advisory Group (NITAG)*, to attend the PMM (24-26 October). The *Chair of the NITAG* is hereby invited to extend her/his stay in Budva to attend the ETAGE meeting (26-27 October).

A proposed scope and purpose and agenda for each of these events will be developed and sent to the nominees.
