Measles and rubella elimination in the WHO European Region - Strengthening countries' capacities to fulfil requirements of the verification process Intercountry meeting, 21–22 November 2017, Copenhagen, Denmark

I have the honour to inform you that the World Health Organization Regional Office for Europe is organizing the above-mentioned meeting, which will take place in Copenhagen, Denmark, on 21–22 November 2017.

The main objectives of the intercountry meeting are to inform country representatives about the current status of measles and rubella elimination in the Region, to review and discuss activities and new developments in the verification process, to provide practical training on the revised reporting form for 2017, to discuss best practices and lessons learned from countries, to conduct technical consultations between VPI, national counterparts and the Regional Verification Commission for Measles and Rubella Elimination (RVC) and to address key measles and rubella laboratory challenges. The meeting will bring together delegations from 12 Member States, and the working language will be English.
