3.	FICCI request email to shortlisted delegates to register on event website within 7 days with complete profile, photograph and copy of valid passport. Concerned mission will be copied in this mail for enabling immediate follow-up.	1-JULY-2016 TO 15-JULY-2016.
4.	Once both 'Registration Received Successfully' and 'Registration As Hosted Delegate Is Approved' emails are received by a delegate on his registered email, Payment of a nominal Registration Fee of USD 100/- is to made online	PAYMENT OF USD 100/- WITHIN 7 DAYS.
5.	Dispatch of Visa Invitation Letter along with Tentative Hotel and Flight details by FICCI with a copy to Indian High Commission. Selected Delegates to immediately apply for CONFERENCE VISA at Indian High Commission.	1-JULY-2016 TO 15-AUG-2016.
6.	Booking of ALL Air Tickets by FICCI.	BY 31-AUG-2016.
7.	Last date of Receipt of scanned copy of VISA by FICCI. Kindly note that Scanned copy of Tickets and Accommodation details shall be mailed to the delegate ONLY UPON RECEIPT OF A COPY OF VALID CONFERENCE VISA.	15-SEPT-2016.
8.	Intimation from FICCI about Airport pick-up facilities to welcome delegates	BY 25-SEPT-2016.

Those delegates who were recommended by your office during the first edition of AHCI 2015 and who had registered but could not attend will be given preference in this edition. Their complete details may be sent to us immediately for consideration. We are keen to host fresh set of delegates but Embassy may also nominate any such delegate who has attended earlier during AHCI 2015 if you deemed fit in the interest of the programme. However, such delegates will be provided only Hotel accommodation and local hospitalities in Delhi and expenditure on both sides air travel will have to be borne by the delegates themselves. We will host 8-10 delegates per country on FIRST COME FIRST SERVE BASIS and subject to appropriateness of profile and approval by the screening committee. A token amount of USD 100/- against refundable registration fee shall be payable online by all approved delegates.

The delegates who are not selected as 'Hosted Foreign Delegate' are welcome to visit on their own. We will waive their conference fee of USD 400/- upon their written request to us.
