I'm a reporter in <u>Polygraph.info</u> and have couple of questions. Last year in October you spoke to Ia Meurmishvili on a similar topic and she gave me your contact.

We are trying to confirm some findings after the speculations given by Igor Giorgadze, the ex-Georgian state security minister, that Lugar Laboratory personnel performed testing on people and that many persons died as a result of this testing in 2015 and 2016.

The documents published by Giorgiadze reveal some facts and we would ask you or your office to confirm what it is about.

- 1. Why those people listed in the Lugar Lab documents died and have they really been victims of "illegal drug testing," as Giorgadze tried to portray at a recent press conference in Moscow.
