With this letter, I would like to outline the importance of the US-Georgia partnership which entailed unprecedented initiative - Hepatitis C Elimination Program in Georgia. This project is a direct result of successful public-private partnership originating from close cooperation between the U.S. Centers for Disease Control and Prevention and Gilead Sciences Inc.. Through universal access to HCV diagnostics and treatment, HCV burden in Georgia is gradually being eliminated. Beyond its immediate public health impact in Georgia, the HCV elimination project will serve as a model for other countries by generating valuable data to support the implementation of elimination programs in other parts of the world.

An unprecedented investment and US Government support has been rendered to Georgia for establishment and operation of the R. Lugar Center for Public Health Research under the National Center for Disease Control and Public Health (NCDC).
