Dear Nino,

Pegasus and LOT are both unrestricted airline, therefore according to CWT offer the most economical route is the policy compliant option which should be used. WHO cannot accommodate traveller's preference of a specific airline. WHO travel policy also requires lowest restrictive economy class fare (such as non-refundable fares) to be used.

Should a traveler wish to travel by choice of airline, it is possible to self-purchase if the non-staff participant agrees to do that. Please see the policy and approval procedure regarding self-purchased tickets here:

The WHO maximum liability would be lowest quote offered by CWT or actual cost of ticket to be self-purchased, whichever is lower. If the traveller finds a self-purchased ticket that is more expensive than WHO maximum liability, then the traveller pays the difference between WHO maximum liability and the self-purchased ticket.
