The meeting will be held in English and Russian. Simultaneous translation will be available.

# 3. Registration, opening session and closure

#### 4. Working hours

#### 5. Documentation

Documentation concerning the meeting will be disseminated prior to the meeting electronically. A participant folder will be provided at registration with a printed version of the provisional programme.

#### 6. Accommodation and meals

Hotel accommodations have <u>not</u> been pre-booked for this event. You are therefore encouraged to book accommodations as soon as possible as there are many events in Almaty during this period. See Annex 1 for a list of hotels within close proximity of the office.

Lunches will be provided by the WHO European Centre for Primary Health Care. There will be two refreshment breaks, morning and afternoon each day.

Special dietary requirements should be communicated on the registration form.

#### 7. Travel tickets and subsistence allowance

For those participants, attending the meeting at the expense of WHO, this office will cover the cost of your ticket for round trip travel by the most direct route, by air (economy class). #### 8. Visa requirements

Since 1 January 2017, the Government of the Republic of Kazakhstan as exempted 45 countries on a unilateral basis for visa's under 30 days, due to the upcoming EXPO 2017. See Annex 2 with list of visa free countries.
