## Calendar of Elaborating the Open Government Georgia's 4th National Action Plan

This calendar outlines the 6-month cycle for Georgia to deliver the Open Government Georgia's 4<sup>th</sup> National Action Plan (NAP) in July, 2018, at the Open Government Partnership (OGP) 5<sup>th</sup> Global Summit to be held in Tbilisi, Georgia. The Government will draft a new NAP jointly with civil society and international partners in the framework of the Open Government Georgia's Forum (Forum) – a permanent dialogue mechanism between the government and civil society to co-create the open government agenda.
