## EMT European Regional Meeting on Strengthening the Emergency Medical Teams initiative For All-Hazards Emergencies Preparedness, Alert and Response Brussels, Belgium 17-18 April 2018

I have the honour of informing you that the World Health Organization Regional Office for Europe, in agreement with the Government of Belgium in its capacity as Regional Chair for 2017/2018 of the Emergency Medical Team (EMT) initiative and the European Commission, plans to hold the abovementioned meeting.

The aim of the workshop is to facilitate discussion and agreement between member states and EMT providers on topics such as EMT coordination, training, exercises and capacity building as well as experience sharing and lessons learnt on regional response operations.
