The Director-General will submit three reports on this matter. The first will provide proposals to improve the efficiency of the governing bodies and their focus on strategic issues. The Board will also consider a second report that provides an analysis of, and proposals relating to, the Rules of Procedure of the Governing Bodies with a view to adopting, or recommending adoption of, amendments thereto, as necessary. Lastly, the Board will consider a third report that sets out the evaluation of the Officers of the Board of their experience in using the criteria and prioritization tool in respect of proposals for additional agenda items.

4.2 Report of the Programme, Budget and Administration Committee of the Executive Board

The Board will receive at the opening of its session the report of the twenty-eighth meeting of the Programme, Budget and Administration Committee, which is scheduled to be held on 17 and 18 May 2018.

4.3 Evaluation: annual report

In line with the current evaluation policy, approved by the Board in decision EB131(1) (2012), an annual report on evaluation will be presented to the Board through its Programme, Budget and Administration Committee. The report will describe progress made in the implementation of the evaluation policy and the Organization-wide evaluation workplan for 2016–2017, and will document organizational learning in respect of recent evaluations. In addition, the Board will be invited to consider a draft evaluation policy (2018) for approval.

4.4 Hosted partnerships

In decision EB132(10) (2013), the Executive Board requested its Programme, Budget and Administration Committee, inter alia, to ensure that the arrangements for hosted health partnerships are regularly reviewed on a case-by-case and timely basis in respect of their contributions to improved health outcomes, WHO's interaction with individual hosted partnerships, and the harmonization of their work with the work of WHO; and to make recommendations for the consideration of the Board, as appropriate, through a standing item on the subject on the Board's agenda.

Report on hosted partnerships

5.2 International classification of diseases

Work to prepare the eleventh revision of the International Statistical Classification of Diseases and Related Health Problems (ICD-11) has progressed since the last update, which was considered by the Executive Board at its 139th session, and the revision is close to finalization. The report by the Director-General will provide an overview of the last steps of the revision process, and of preparations for facilitating both implementation to generate input based on practical experience and submission of the final version of ICD-11 to the Health Assembly.
