- Discussing the potential big medical co-op projects with Georgian Ministry of Health in terms of using China Funds to upgrade and improve medical imaging facilities in the whole country.
- 2) Building up or reunion high-ending comprehensive "Diagnosis/Health Checking Center plus Clinic" in Georgia. The overall functions of this 'Center+Clinic' will be more comprehensive than other local general clinics and hospital, including for example, all body-checking medical equipment/devices, software/IT technologies, audio-visualization trainings, tele-medicine diagnosis reports between China and Georgia (by using advanced Neusoft technology), etc.
- Discussing two-sided Medical Exchanging Programs between China and Georgia:

 For example, co-organizing Medical Conferences, which means Chinese medical delegation including experts, medical companies (e.g. Neusoft) will go to Georgia, and meet with Georgian side public and private medical organizations, clinics/hospitals, for mutual interested topics and directions in medical and public health fields;

 Also, China-side can invite Georgian delegations come to China for medical related trainings and literature seminars; Under China Ministry of Commerce and Ministry of Health, there are a series of "One Belt One Road" Medical Training programs.
- 4) Medical Tourism and expanded field's investment in Georgia:
 Discuss to develop suitable medical tourism programs between China and Georgia for example: the investment medical project about the "Rehabilitation Center", and other good programs that Georgian side would advise.



5) Neusoft would like to discuss with Ministry of Health about the purchasing process for medical imaging diagnosis equipment in Georgia?
