#### Scope of Services

The Contractor shall deliver 3 New Carrier cum Passenger Vehicles [2 vehicles with 5 seating capacity and 1 Vehicle -with 2 Passenger seating capacity cabin] to the U.S. Consulate General, Hyderabad, India.

#### 1. TYPE OF CONTRACT

This is a firm fixed price contract payable entirely in the currency indicated in Section 3, Sub-Section 3.2, of the purchase order. No additional sums will be payable on account of any escalation in the cost of materials, equipment or labor, or because of the Contractor's failure to properly estimate or accurately predict the prices or difficulty of achieving the results required by this purchase order. Nor will the purchase order price be adjusted on account of fluctuations in the currency exchange rates.

#### 2. EFFECTIVE PERIOD OF PURCHASE ORDER

The purchase order shall be effective on the date of the Contracting Officer's signature, and shall remain valid until vehicles have been received and accepted by the U.S. Government, and in accordance with Section 9 "Delivery Schedule" of this document.

#### 3. SUPPLIES AND PRICES

The Contractor shall provide to the U.S. Government 3 (Three) new right hand drive (EURO- IV or higher) Carrier cum Passenger vehicle (5 and 2 seater) OR equal described in the specifications. Further, the Contractor shall properly perform pre-delivery inspection on the vehicles and deliver them to the location set forth in Section 10, Place of Delivery, of this purchase order. The firm fixed price shall include the vehicles, pre-delivery inspection, and transportation to their ultimate destination, certificates of origin, operator's manuals, warranty certificates, and any other documentation mandated by the destination country in accordance with Section 5, Other Specific Requirements, of this purchase order. All manuals shall be furnished in the English language.

#### 3.1 PRICING DATA

The offerors shall insert their prices for the subject vehicles below. The prices shall include transportation of the vehicles to the US Consulate General - Hyderabad, India in accordance with Contract Clauses, under FAR 52.247-42, C.I.F. Destination (April 1984), of this contract.

#### **SECTION 2 - CONTRACT CLAUSES**

  - (4) Furnishing information about whether any person has, has had, or proposes to have any business relationship (including a relationship by way of sale, purchase, legal or commercial representation, shipping or other transport, insurance, investment, or supply) with or in the State of Israel, with any business concern organized under the laws of the

State of Israel, with any Israeli national or resident, or with any person which is known or believed to be restricted from having any business relationship with or in Israel;

- (5) Furnishing information about whether any person is a member of, has made contributions to, or is otherwise associated with or involved in the activities of any charitable or fraternal organization which supports the State of Israel; and,
- (6) Paying, honoring, confirming, or otherwise implementing a letter of credit which contains any condition or requirement against doing business with the State of Israel.

  - necessary equipment and facilities or the ability to obtain them; and
  - be otherwise qualified and eligible to receive an award under applicable laws and regulations.

# ADDENDUM TO EVALUATION FACTORS FAR AND DOSAR PROVISION(S) NOT PRESCRIBED IN PART 12

The following FAR provisions are provided in full text:

## 52.217-5EVALUATION OF OPTIONS (JUL 1990)

The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. Evaluation of options will not obligate the Government to exercise the option(s).

"Place of manufacture" means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government.
