- A. The purpose of this firm fixed price purchase order is to contract Public's affairs professional services for the Salvadoran attorney's general office (FGR).

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

BACKGROUND

Services has as main objective to help El Salvador's FGR to improve the capacity of the Attorney General's Office to effectively manage communications and share safe and vetted information with the media and public, and a strong public relations strategy.

DESCRIPTION OF SERVICES REQUIRED

1. Design relevant tools to implement a structured communications and public relations engagement strategy (Actors Map, Strength, Weaknesses, Opportunities and Threat (SWOT) Analysis, Situational Analysis and Timeline). Setup a Working Group from the Attorney General's Office and other qualified experts to set and decide the areas of focus, as well the institutional work required to implement the strategy at the level of public prosecution, budget, institutional policies and projection.

In order to accomplish these tasks, we require the bidders to:

- Coordinate 12 training/advisory sessions to create an Actors Map document and update it as required.
- Coordinate 12 training/advisory sessions to develop an Opportunities and Threats (SWOT) analysis document for public relations and keep it updated based on emerging cases and events.
- Work with the Attorney General's Working Group on developing and keeping a situational analysis bi-monthly report.
- Coordinate with the Crisis Management Subject Matter Expert and the Attorney General's Working Group 24 training/advisory sessions for the implementation of the Communications and Public Relations Engagement Strategy and its tools.
- Define with the Attorney General a Crisis Working Group. Establish trusted vetted members, and set goals, timelines, and objectives for the group.

2. Development and implementation of an external engagement and communications strategy along with actors from Washington D.C., the United States Embassy in El Salvador and Non-Governmental Organizations.

Creation and implementation of Communications, Public Affairs Engagement, and Crisis Management Strategy design.

In order to accomplish this, we require bidders to:

- Coordinate 2 visits to Washington D.C. to meet with specific actors to build an engagement strategy to support the Attorney General's Office.
- Create a Washington, D.C. engagement strategy document.

- Coordinate 2 NGO engagement training sessions to improve the working group skills to get support and sponsorship from NGOs and other stakeholders.
 - Coordination of 24 training/advisory sessions with the Attorney General Working Group to develop and revise the communications, political engagement, and crisis management strategy.
 - Creation of the communications and public affairs engagement strategy document to be presented to the AG and the INL Section.
 - Creation of a Crisis Management Strategy Document to be presented to the AG and the INL Section.
3. Development and implementation of a system for safe and vetted information sharing.
- Create a control and confidence policy and vetting process within the FGR to vet prosecutors depending on the level of access to sensitive information their job requires.
 - Coordination of 12 training/advisory sessions to develop and implement a vetting process for information released to media and public.
 - Deliver 4 workshops to the Attorney General's working group and other stakeholders to discuss and share best practices in the region on how to confront public affairs challenges and to develop a system for best practices sharing with Prosecution's Offices in Guatemala and Honduras.

MINIMUM REQUIREMENTS

Bidding companies, consultants or individuals must comply with the following requirements:

- Attorney at law and notary required. International Relations and/or Journalism Diploma required. Master's Degree in Communications, Public Relations, or other related field desired (For companies: Ability to designate at least one qualified individual in each of these fields is required).
- Must have proven experience in developing and implementing communication strategies for attorneys general in northern triangle governments.
- At least one individual must be assigned permanently to work in the Attorney General's office to provide these services. No other job should be accepted during the expected duration of this contract (6 months) by this individual. Additional experts may consult.
- Must have proven experience in Communication Strategies and Public Affairs Crisis Management.
- Individual must be proficient Spanish Speaker Level 4/4 (Native Speaker) and English Level 3/3 (working knowledge) is required.
- Must have strong understanding of El Salvadoran government and the important political players in the country.
- Preferred experience working with the current Attorney General.

PERIOD OF PERFORMANCE

Services must be provided during an initial Six Month period. The INL Section anticipates that this project will begin on September 1st, 2018.
