#### STATEMENT OF WORK

#### INL SAN SALVADOR - VEHICLE WRAPS FOR G.R.E.A.T. PROGRAM

#### A. GENERAL REQUIREMENT

Truck Wraps for G.R.E.A.T., shall be printed on a high quality vinyl Controltac with UV for protection.

Period of performance: Will be for a one-time services contract consisting of editing, producing, printing, delivering, and installing (35) wraps on 35 PNC Vehicles. The contractor shall produce, edit, print, and install all 36 wraps, tentatively within 30 calendar days after the awarding of the contract or on a date chosen by the INL.

#### SPECIFIC REQUIREMENT

- The contractor shall produce a prototype, not installed on the trucks, to present to the INL for approval, no later than 7 calendar days after the award of the contract.
- The contractor shall ensure that the image is, or will be properly fitted on the vehicles, and scaled to fit the size of the trucks by taking measurements of the vehicles prior to installation.
- The contractor shall agree to adapt the size of the provided image to the size of the wraps/vehicles without having to alter the quality of the image itself while making sure the wraps properly fit the vehicles.
- All logos, text, and images must provide exceptional quality and be easy to read
- The measurements of the banners are the following according to the vehicle model described below.
- 1. **11 each** Printing and installation in full color (Laminated Controltac Uv Protection) for Hi Ace:

- 3. **6 each** Printing and installation in full color (Laminated Controltac Uv Protection) for Pick Up Hilux:

- (2) The Contractor shall make available at its offices at all reasonable times the records, materials, and other evidence for examination, audit, or reproduction, until 3 years after final payment under this contract or for any shorter period specified in FAR subpart 4.7, Contractor Records Retention, of the other clauses of this contract. If this contract is completely or partially terminated, the records relating to the work terminated shall be made available for 3 years after any resulting final termination settlement. Records relating to appeals under the disputes clause or to litigation or the settlement of claims arising under or relating to this contract shall be made available until such appeals, litigation, or claims are finally resolved.
- (3) As used in this clause, records include books, documents, accounting procedures and practices, and other data, regardless of type and regardless of form. This does not require the Contractor to create or maintain any record that the Contractor does not maintain in the ordinary course of business or pursuant to a provision of law.
- (e)(1) Notwithstanding the requirements of the clauses in paragraphs (a), (b), (c), and (d) of this clause, the Contractor is not required to flow down any FAR clause, other than those in this paragraph (e)(1) in a subcontract for commercial items. Unless otherwise indicated below, the extent of the flow down shall be as required by the clause—

- (a) The Contractor shall comply with the Department of State (DOS) Personal Identification Card Issuance Procedures for all employees performing under this contract who require frequent and continuing access to DOS facilities, or information systems. The Contractor shall insert this clause in all subcontracts when the subcontractor's employees will require frequent and continuing access to DOS facilities, or information systems.
